### **School will:**

- Provide information to parents of participating students in an understandable and uniform format.
- Provide to parents of participating children information in a timely manner about Basic Skills programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet.
- On the request of parents, provide opportunities for regular meetings for parents to formulate suggestions, and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible.
- Provide to each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading.
- Provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002).

### **Parents and guardians are asked to give support in the following ways:**

- Join parents' organizations (i.e. HSA or Educational Foundation).
- Review the monthly Principal's Newsletter (hard copy/ on-line) for updates.
- Review the monthly web pages.
- Utilize on-line resources for information about your child or school programs.
- Talk about review homework planners nightly to check completion of homework assignments.
- Attend school events.
- Make an appointment to seek assistance from teachers to intervene in possible problem areas.
- Attend parent-teacher conferences and request additional meetings, if needed.
- Keep teachers informed about events and issues that may affect your child's work or behavior.
- Read to your child and talk with him/her or her about what you are reading.
- Limit time spent playing video games and using computer devices for social networks.
- Limit TV time and monitor the quality of viewed to ensure they are appropriate.

### **Staff and Parent**

Parents/caregivers will be informed of school activities through various avenues of communication throughout the school year, and will be consulted in the implementation of the Basic Skills program. Monthly newsletters, teacher notes, the school sign, conferences, personal contacts, phone calls and written notices will be used to establish and maintain open lines of communication with parents/caregivers. Every parent/caregiver of a Basic Skills student will receive information outlining the results of Dynamic Indicators of Basic Early Literacy Skills (DIBELS), Developmental Reading Assessment (DRA), and NJ-ASK testing that will specify the areas of needed instruction. The Basic Skills teachers will maintain a record of parent contacts throughout the school year updating them of their child's progress.

### **Evaluation**

Parents will be surveyed, including input of the effectiveness of the program, and the results reviewed. The Indian Mills Elementary School will revise the Parent Involvement Policy based on the results of the annual review.
